IP Hires: Crowell & Moring, Gibson Dunn, Skadden

Law360 (February 16, 2018, 5:35 PM EST) -- In this week's intellectual property partners on the move, Crowell & Moring boosts its ranks with the addition of a seasoned patent litigator, Gibson Dunn lands a new partner with a high-profile IP and technology transactions practice, and Skadden snags the former leader of Quinn Emanuel's trade secrets practice group. Here are the details on these and other notable IP hires.

Crowell & Moring Boosts NY Office With Ex-Kirkland IP Atty

Crowell & Moring LLP added to its intellectual property group's New York office with the addition in late January of former Kirkland & Ellis LLP partner Brian Paul Gearing, who brings with him more than a decade of experience in IP litigation and patent portfolio management.

The new partner will mainly focus his practice on IP litigation, including patent litigation before federal district courts and the U.S. International Trade Commission, as well as trade secret, trademark and copyright disputes. He'll advise clients in connection with IP portfolio management and adversarial patent licensing negotiations, and opinion work regarding noninfringement and invalidity.

Gearing told Law360 he was particularly impressed by Crowell & Moring's "talented and deep" bench of lawyers, many of whom he's worked with over the years or gotten to know through reputation.

Gibson Dunn Scores IP Transactions Partner in Silicon Valley

Gibson Dunn & Crutcher LLP has nabbed former White & Case LLP partner Carrie LeRoy, who will join the firm's Palo Alto, California, office and represent clients in complex intellectual property licensing and cross-border and commercial transactions.

Quinn Emanuel's Trade Secrets Chair Jumps to Skadden

Skadden Arps Slate Meagher & Flom LLP has snagged the head of Quinn Emanuel Urquhart & Sullivan LLP's trade secrets practice group to join the firm's Palo Alto, California, office.

John "Jay" Neukom will serve as a partner for Skadden's intellectual property litigation team, specializing in trade secrets and patent cases. In his 13 years of practice, his clients have included Google Inc., Cisco Systems Inc., AT&T Inc., The Bank of New York Mellon Corp. and Koninklijke Philips NV.

Neukom's experience representing a range of tech companies in state and federal court, and before arbitration panels, made him an attractive candidate, Skadden IP

Ropes & Gray Lands New Life Sciences IP Practice Chair

Ropes & Gray LLP has a new chair of its life sciences intellectual property practice in New York after bringing on board Filko Prugo, who previously helped launch, and led, O'Melveny & Myers LLP's Hatch-Waxman and Biologics Price Competition and Innovation Act practice.

The litigator has spent 20 years representing top pharmaceutical companies in IP litigation before federal district and appellate courts, as well as the Patent Trial and Appeal Board. He's led the team on at least 20 trials, Ropes & Gray said.

His successes include a win for Novartis Pharmaceuticals Corp., which had alleged that Watson Laboratories Inc. infringed a patent when filing an abbreviated new drug application to make a generic of Novartis' dementia treatment Exelon; getting Sandoz Inc. to hold off a generic version of AstraZeneca PLC's breast cancer drug Faslodex; and winning inter partes reviews for AstraZeneca.

"When the opportunity to join Ropes & Gray in a leadership position presented itself, it seemed like a natural next step," Prugo said in a statement. "My extensive chemistry and biotech patent litigation experience nicely complements the firm's strong focus on the life sciences industry."

Loeb & Loeb Boosts Life Sciences Practice With 3 Hires

Loeb & Loeb LLP recently landed a trio of new attorneys to its life sciences practice, including senior counsel Ryan N. Hagglund, who is a patent litigator focused in the pharma and biotech industries.

He works largely on Hatch-Waxman and biotech litigation, but has also advised on patent licensing, copyright, trade secrets and transactions, the firm said.
